#### **Payment Option**

An automatic payment plan for Kingston Water Department Rate payers at no extra charge!!

We encourage you to consider enrolling in our Electronic Funds Transfer (EFT) payment plan. Your water bill payment will be electronically transferred from your bank account to Kingston Water Department, saving you both time and money. There is no trip to the post office, no more last minute trips to the Water Department and no check to write. EFT also saves you the expense of envelopes, stamps and gas.

It is a simple way to pay your water and sewer bill by having it deducted from your bank account and paid directly to Kingston Water Department. Because the total amount due for your water and sewer bill is automatically withdrawn, EFT insures timely payments, preventing the 10% late penalty. And your payments are taken care of even if you are out of town.

#### **It is easy to enroll on our EFT payment plan.**

To have your water bills paid through our EFT option, just complete, sign, and return the EFT authorization form on the reverse side of this sheet. Be sure to include a voided check from the account you wish to make payments from. Once your EFT form is processed by us, your payments will be deducted from your account by your bank.

#### **Our EFT payment plan makes life just a little simpler for you.**

EFT payment option is offered as a convenience for all Kingston Water Department customers. Enrollees will continue to receive a paper bill each quarter. The bill will state – **DO NOT PAY-PAID BY ELECTRONIC FUNDS TRANSFER ON DUE DATE**. Payment will be deducted from your account by your bank on the due date stated on your bill. **No more due dates to remember!! No more late fees assessed!!**
