Music in the Parks is a free, family-oriented concert series funded by the City of Kingston. Concerts will be held at various Kingston park locations from 6pm-830pm on Saturdays during the summer. The venues are outdoors with lawn seating for @ 50-100 persons. We supply the stage area and electricity. Performers must bring their own sound equipment, instruments, microphones, stands, cables, extension cords, and power strips. We prefer full bands with a minimum of four members. Duos and trios will receive consideration as well. We do not consider soundtracks. Our audiences are typically children, families, and seniors. Selected ensembles will receive an honorarium. A service agreement and W9 must be signed and submitted to the City.
