# RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF KINGSTON, NEW YORK, TO ADOPT A MEMORIALIZING RESOLUTION CALLING FOR AN IMMEDIATE AND PERMANENT CEASEFIRE AND UNITING FOR PEACE.

WHEREAS, the City of Kingston is united against all forms of violence and recognizes that all life is precious; and

[Except Jewish life.]

**WHEREAS,** the City of Kingston condemns all forms of racism, including but not limited to anti-Semitism and anti-Arab racism, islamophobia, fascism, white supremacy, anti-indigeneity, and xenophobia throughout the world; and

[Jews are the indigenous people of Israel, and calling out radical Islamist terrorism is not Islamophobic - there is no moral equivalence here.]

**WHEREAS**, the City of Kingston aspires to be a safe and welcoming community and is committed to promoting peace, unity, and respect for all residents and community members; and

[Bullshit - this is directed as Jews and Israel.]

**WHEREAS,** according to the United Nations World Food Program . . . people have been displaced from their homes, and there is a continued lack of food, healthcare, and potable water that has led to famine; and

**WHEREAS**, the City of Kingston recognizes the urgency of the human rights crises in Palestine and Israel and the need for immediate action; and

**WHEREAS**, the conflict in the Middle East has greatly affected many members of our Kingston community in the most intimate and horrifying ways; and

**WHEREAS**, the City of Kingston recognizes that we have the ability and opportunity to help ease the pain and divisions within our community through a statement of shared understanding.

Dear Members of the City of Kingston Common Council

As a homeowner in Kingston (on W. Chester St), I feel extremely lucky. Not only do I get to live in our vibrant community, but my monthly costs are relatively stable thanks to choices made by various state, local, and federal policy makers:

- The 30-year fixed-rate mortgage is a product of federal policy in the New Deal era and my low rate is a product of the low interest rate environment between 2009 and 2021.
- My homestead tax rate is low relative to non-homestead parcels in Kingston because of the decisions this council and other local bodies have made to set those rates differently.
- My tax rate is relatively stable year-over-year because of the deliberate and prudent financial decisions this council has made to balance spending against diverse revenue streams.

For all that, I should start this note with a big THANK YOU!

But many of our neighbors don't benefit from this constellation of decisions that make my comfortable life cheaper and more predictable. The rental real estate market in Kingston has turned unpredictable and unaffordable for ordinary people.

I've seen this in my work as Interim Executive Director of the Ulster Way of United County this spring and in my service as Chair of the Kingston Rent Guidelines Board. While these reflections are shaped by those roles, I want to be clear: I'm writing to you on my own behalf and in this letter speak only for myself, not as a representative of any organization or body.

With the generous support of this council's allocation of ARPA funds and various other local philanthropies, the United Way operates an emergency fund where residents can seek one-time assistance to pay bills that would, left unpaid, destabilize their lives. This spring, I had the responsibility of signing check after check primarily to landlords and Central Hudson for our neighbors who had fallen behind on their housing costs because of illness, injury, temporary job loss, or other emergency.

Even an ordinary challenge will mean that you can't make rent when – like about a third of our community – rent is more than half your income. It's hard to imagine building the financial stability and resilience needed to weather a cancer diagnosis or major car repairs when your rent expense goes up twice as fast as your income, as Pattern for Progress reports happened in our county last year.

The City of Kingston Common Council is doing a lot to respond to this housing emergency, as I well know. You declared an emergency pursuant to the Emergency Tenant Protection Act and have defended that decision in court, empowering the board that I chair to cap allowable rent adjustments in less than half of the City's rental units (only buildings completed before 1974 that have six or more units). You've passed a visionary zoning plan that hugely expands the possibility of creating new housing. You've made a pipeline of renovated and affordable homes in partnership with the Kingston Land Bank. You've continued to make decisions to encourage and subsidize creation and maintenance of affordable housing one project at a time, too.

All of this is laudable, but given the scale of the crisis we must continue to take every opportunity to address it.

This week, you have the opportunity to adopt additional tenant protections that extend protections against unjust evictions and rent gouging to tenants in unregulated buildings. More than half of tenants in Kingston live in buildings with 1-4 units that are not protected by the Rent Guidelines Board's determinations of what a fair rent adjustment is in a given year. This is the population of tenants that most needs Good Cause Eviction – but if the law is written to exclude landlords with four or fewer units in their portfolio, then the majority of them will never get basic protections.

The Good Cause law already excludes truly small landlords – people who live in their property and rent out other units are exempted. Any definition of a small landlord portfolio other than one unit opens the door to confusion for tenants who won't be able to confirm how many units their landlord owns, and opportunities for property owners to skirt the law's intentions.

I urge you to adopt the most expansive possible tenant protections this week. It won't be enough. Good Cause, as enacted by the state legislature, sets an unreasonably high threshold for challenging rent increases. Enacting these tenant protections, like opting in to the protections of ETPA for eligible buildings, is your responsibility but it does not end your responsibility.

You have heard, as my colleagues on the Rent Guidelines Board and I heard, the challenges of landlords facing their own cost challenges. These are real, of course, but the evidence that the Rent Guidelines Board had in front of it produced from surveys sent to landlords suggests that the increased costs and tightened belts that landlords describe are not present in the hard facts. For the ETPA-covered buildings that responded to DHCR's survey, costs declined slightly in the last year while operating margins meaningfully increased. Kingston building owners have significantly larger operating margins that those in Westchester or other ETPA counties.

Good Cause will provide some measure of protection for tenants and will not constrain landlords' ability to maintain their operating margins; you should adopt it.

And then continue to pursue every available opportunity to provide tenants the stability that local, state, and federal policies have provided me as a homeowner.

## Assemblymember Shrestha's Written Comments on Local Law 5 of 2024: Prohibiting Eviction Without Good Cause

New York State passed a version of good cause eviction through the state's budget that allows municipalities outside of New York City to opt-in. While this version leaves out thousands of upstate tenants in places where such an opt-in is unlikely, I always knew the City of Kingston would provide a glimmer of hope as one of the first localities to opt-in. I knew this because Kingston has led the state in tenant protections with the Rent Guideline's Board historic decision to reduce rent and by passing a local version of good cause protections in 2022.

During budget negotiations, a provision I fought diligently for allows municipalities to consider local conditions when defining the exemption based on the number of units in a landlord's portfolio—what it means to be a small landlord in New York City is not the same as what it means in Kingston. I'm thrilled that the currently-proposed Local Law 5 only exempts landlords who live on the premises or who only own one unit. I am writing today to encourage the Kingston Common Council to maintain that exemption.

State legislators and lawyers who argued against last minute compromises to the state's good cause law strongly believe that exempting portfolio sizes at a higher number of units will lead to the law not being enforceable or effective at all because of the prevalence of landlords who hide behind multiple LLCs. Though we passed the LLC Transparency Act last year, it will be several years before a directory is created, and the directory won't be disclosed to the public, due to changes the Governor made to the law before signing it. The only way the council can ensure Kingston tenants are protected under good cause is by covering tenants with landlords who own more than one unit. According to American Community Survey data, 60% of tenants in Kingston live in buildings with 1-4 units, so increasing the portfolio size exemption would leave out a significant number of renters.

The intention of the good cause law is to help stabilize neighborhoods by giving tenants a defense in court if their landlord tries to raise the rent by more than 10 percent. I trust that the intention of the Kingston Common Council is to protect tenants against price-gouging, and passing Local Law 5 as-is will do just that.

Written Testimony to the Kingston City Council regarding adoption of Good Cause Eviction protection.

From the Hudson Valley Justice Center

On July 2, 2024 the Kingston City Council has the opportunity to extend good cause eviction protections to the majority of tenants within the City of Kingston by adopting Section 213 of Article 6-A of the Real Property Law of the State of New York. This testimony is intended to explicitly provide legal and policy support for defining a "small landlord" as any landlord owning one (1) rental unit in the state of New York.

Real Property Law Section 213(2)(b) authorizes municipalities to "define 'small landlord' as a landlord of no more than *any number* of units in the state that the village, town, or city enacts by local law, provided that if such local law does not define 'small landlord,' a 'small landlord' shall mean a landlord of no more than ten unites in the state." RPL 213(2)(b) (emphasis added). This statutory language grants the City of Kingston broad authority to define a small landlord based on the realities of its own local housing market and in such a way as to ensure that landlord cannot exploit loopholes in the law to deny otherwise eligible tenants the protections of this law.

In order to ensure the efficacy of Good Cause Eviction protection within the City of Kingston, the Council should define a small landlord as any landlord owning one (1) rental unit within the state for the following reasons:

- The vast majority of tenants in the City of Kingston live in buildings with less than 5 units. Specifically, 60% of tenants live in buildings with 1-4 units. These units are already exempted from the Emergency Tenant Protection Act, which the city recently adopted, so opting into Good Cause and defining "small landlord" at one unit will ensure that these tenants receive some form of protection against evictions without cause.
- 2. Setting the "small landlord" definition at one unit does nothing to disturb the exemption provided to landlords who reside within the building they are renting to be exempted from the Good Cause Eviction law if their building has fewer than eleven units. The State Legislature has already sought to strike a balance between tenant protection and the property rights of landlords by carving out a large exemption for owner-occupied buildings.

3. Landlords routinely transfer ownership of their properties to LLCs. It is not uncommon for landlords to create separate LLCs for each building they own. If the City of Kingston defines a "small landlord" at a threshold above ownership of 1 unit, landlords will be able to obscure the size of their rental portfolio through distinct LLCs. While the law does state that separate LLCs with shared managing agents are deemed a single landlord for the purposes of determining portfolio size, there is no publicly available database of LLCs in the state of New York where tenants can look to determine whether their landlord owns other properties through different corporate entities. Furthermore, the majority of tenants who face eviction are unrepresented in their court proceedings and, without the assistance of counsel, it is unreasonable to expect that pro se tenants will be able to litigate the intricacies of their landlord's various corporate holdings to expose whether they are rightfully entitled to the protections of the law. Furthermore, even when a tenant does have representation in an eviction proceeding, the loophole created by defining a small landlord any higher than one unit would remain a substantial vulnerability for tenants because there is no right to discovery in housing court proceedings. As a result, a tenant would have to be able to present prima facie evidence that their landlord may own additional units in order for the court to even consider allowing a tenant to seek the discovery to establish whether the tenant is entitled to protections of the law. Without discovery, tenants and their representatives are left to rely exclusively on the landlords' compliance with Section 214 of the Good Cause law, which requires disclosures but imposes no statutory penalties for failure to do SO.

If the city of Kingston is serious about extending protection against evictions without cause to the residents of this city, then the Council must define a "small landlord" as the owner of one rental unit in order to avoid creating a loophole that would create an opportunity for landlords to deny those protections to tenants through manipulations of their corporate structures.

Some have expressed concern that the City must demonstrate "a rational basis" or other legislative purpose to justify how to define a "small landlord." As a preliminary matter it is important to point out that the statute does not sett any such standard. Moreover, the statute explicitly authorizes municipalities to define "small landlord" as an owner of *any number* of units within the state. However, it is our hope that the above articulated reasonings for defining "small landlord" at one unit will help ease such concerns and

provide the City with ample basis to defeat any challenges, litigative or otherwise, to the decision to adopt good cause and define a "small landlord" as the owner of just one rental unit within the state.

Thank you for considering this written testimony and I welcome any opportunities to speak directly with members of the Council on this matter in the future.

Dear Council members:

Here is a link to the newest United Nations report on water, food and services in Palestinian-ruled Gaza. It notes that famine has been averted in northern Gaza, through increased aid to the residents, though the situation remains extremely dangerous. In light of this, the UN view has shifted since the first proposed resolution. Common Council Members,

While in general I think the push by some in our community to pass this resolution has exacerbated the polarization in our community, I want to thank the community members that have worked to balance the perspective and re orient us towards our own affected community members. In general I don't support the council passing a resolution, but this may be the best version we're going to get if we do.

I take exception to the fourth clause's statement "...which has led to famine". The U.N. based their information on the FEWS NET Integrated Food Security Phase Classification, which warned of imminent famine (not current famine). That report just underwent an internal investigation by the Famine Review Committee. The review states "The FRC has some concerns with the methods by which the situation with regard to food availability in northern Gaza was calculated, which, combined with an incomplete understanding of food access makes the FEWS NET conclusions tenuous." And that many of the predictions of famine "are not supported by the available evidence for the current period of analysis." The FRC review also estimates that Gaza would have 109% of its caloric needs met according to its low estimates – 157% at its high estimate by that data excluded by the FEWS NET report. The report is available on <u>ipcinfo.org</u>

This is not to dismiss the suffering or lack of food security that Gazans are facing at the hands of many actors, and the current classification is still at "risk of famine". But at no point has there been famine, there *has* been a significant and meaningful increase of aid, and at best there just isn't a clear picture yet. This resolution should not include statements that are not fact.
