Dear President Shaut,

I am pleased to provide this 6-month update to the Common Council on the implementation of Kingston's new zoning code.

First, I remain as excited as ever by our new form-based zoning code and am immensely proud that the Common Council unanimously adopted approved the code's adoption. As the Times Union noted in an editorial ("Big Progress in Little Kingston" published August 10, 2023), the new zoning code will "improve lives and set an example for other cities to follow."

Since August 2023, we have continued to maintain an online zoning hub on the City's Engage Kingston platform (https://engagekingston.com/kingston-forward). The page includes an interactive map, guides on how to use the zoning code, various short guides (such as how to open a neighborhood business or how to build an accessory dwelling unit), and many other resources. In September, we sent out a Citywide postcard letting residents and property owners know that the zoning code is now in effect.

In 2023, the City approved a total of **90 housing units across six different sites** under the new form-based code. In January, the Mayor announced a new goal to approve 1,000 housing units between 2024 and 2029.

Based on the approvals to date, I am confident that the new zoning code will enable the City to meet this goal. Further, my Department, Planning, and Building and Safety continue to receive new inquiries from property owners looking to develop housing in the City because of the opportunities provided by the new code. This includes ADUs, "missing middle" housing types including several fourplexes, and several larger mixed-use infill projects throughout the City. As property owners are ready, I am optimistic that these projects will be approved in the coming months and years.

In partnership with RUPCO and Ulster County, the City of Kingston received a grant from New York State Division of Homes and Community Renewal to help encourage the development of ADUs in the County. Four homeowners in the City were selected for the program, however, we received over twenty eligible applications from other homeowners that were not selected. We also hosted an accessory dwelling unit design competition and received designs from 27 architectural teams from across the State. Both these programs speak to the interest that I have been hearing from many Kingstonians about ADUs and other housing types that the new zoning code broadly legalized.

I have been working closely with the Planning and the Building Safety Departments to ensure that the zoning code is being implemented properly and that we are coordinating as needed on development approvals. To facilitate this interdepartmental coordination, we are now meeting on a biweekly basis to review planning and permit requests. Part of the interdepartmental coordination also includes discussion on any potential future refinements to the code. To facilitate this process, I will be asking the Common Council to appoint public members to a Zoning Code Working Group.

The zoning code includes new short-term rental rules. Shortly after the form-based code was passed, the City launched a new online platform via GovOS to facilitate compliance with these rules. As of February 1, the City has received the following registrations:

- Short-term rental full permit: 101 issued out of a total cap of 106
- Short-term rental resident-occupied permits: 12 issued (no cap)
- Short-term rental limited permits: 11 issued (no cap)

In partnership with the Building Department and Corporation Counsel, I will continue to ensure that all properties comply with the registration rules. However, most short-term rental operators have conformed to the new standards.

If you have any questions, please do not hesitate to contact me. I would be glad to discuss this further at the appropriate Committee in February.

WHEREAS, The of Kingston has entered into a grant agreement with the New York State Community Development Block Grant program for the operation of the Mobile Mental Health Program.
