A Fee Waiver is available to candidates who meet the requirements and verterans.

It is the applicant's responsibility to clearly show that they meet the minimum qualifications for the position. Please do **NOT attach a resume to the application.** You are responsible for completing all sections of the official application. Ambiguity and vaqueness will NOT be resolved in your favor.

**PLEASE NOTE:** The City of Kingston and Ulster County are separate Civil Service agencies. Please make sure you are applying for the exam at the correct agency. If applying for both agencies, please see the 'Cross-filing' section further in this announcement.

STARTING SALARY: \$53,988.30

RESIDENCE REQUIREMENT/PREFERENCE IN APPOINTMENT: An applicant must at the time of examination and for at least one month prior thereto be a resident of the municipality in which appointment is to be made or any reasonable combination of municipalities both in and outside of New York State contiguous to the municipality in which appointment is to be made. Residence requirements may be suspended or reduced by the Commission in cases where recruitment difficulty makes such requirements disadvantageous to the public interest. Preference in certification to residents of a municipality pursuant to subdivision 4-a of Section 23 of Civil Service Law may be given 30 days prior to the date of certification of the eligible list.

#### TO TAKE THE EXAM:

Graduation from high school or possession of an equivalency diploma

#### LICENSES AND CERTIFICATION REQUIREMENTS TO BE CERTIFIED FOR INTERVIEW AND APPOINTMENT:

- Must possess a current and valid NYS EMT which must be on file with this Civil Service Office.

  -Your name will remain restricted on this established eligible list until a copy of the abovementioned certification is on file with this civil service office.
- Must possess a current and valid NYS driver's license and must maintain said license throughout the duration of career with the City of Kingston Fire Department must be on file with this Civil Service Office.

### LICENSES AND CERTIFICATION REQUIREMENTS BEFORE THE END OF PROBATION

- Firefighter Certification
- Paramedic Certification

**BACKGROUND CHECK**: Applicants may be required to undergo a State and National criminal history background investigation, which may include a fingerprint check, and/or a polygraph test to determine suitability for appointment. Failure to meet the standards for the background investigation may result in disqualification.

It should be noted that in addition to the written examination, an assessment of an individual's physical ability and physical agility would be made. Candidates should, therefore, be aware that an offer of employment is contingent upon the passing of an appropriate psychological examination, medical examination, agility test, and color vision test. Candidates should also be aware that they are required to maintain a valid New York State Driver's license throughout their employment with the Fire Department.

<u>DUTIES:</u> The work involves responsibility for responding to fires, medical emergencies, and other calls for service. Under direct supervision, an employee in this class learns to perform professional firefighting work, which is of a hazardous nature, to protect life and property. This position is a training level position for the Firefighter Paramedic-Trainee. During the trainee period, the employee must be enrolled in and complete a paramedic level training program. The trainee may advance to the Firefighter-Paramedic position without further examination upon receipt of full paramedic level certification. The firefighter work is performed under the direct supervision of superior officers and in conformance with department regulations and standard operating procedures. Daily assignments, administrative matters, routine equipment, apparatus and station maintenance and custodial work are also under the direction of superior officers. When not engaged in firefighting, paramedic training, routine station maintenance and custodial work, may be assigned to perform basic life support level emergency medical treatment to individuals who are injured in a pre-hospital setting in accordance with NYS laws and regional protocols and under the direction of a physician medical director. Does related work as required.

**ESSENTIAL PARAMEDIC TRAINEE:** Responds to medical emergencies; performs primary and secondary physical assessment of ill or injured persons; treat patients in accordance with the Regional Emergency Medical Organizations Protocols, New York State Department of Health Basic Life Support Protocols and City of Kingston Fire Department policy and procedures; operate radio-telephone equipment and communicates medical information to receiving hospital medical personnel and others; compile necessary reports and records; respond to and perform skilled tasks at the scenes of emergency calls and non-emergency calls.

<u>VACANCIES:</u> List where the position(s) to be filled are- City of Kingston.

This Examination is being held to establish an Eligible List to fill future vacancies in this title, which may occur during the life of the Eligible List. An eligible may receive only one Permanent appointment from this Eligible List. If an eligible accepts a Contingent-Permanent appointment, their name will be removed from the Eligible List only for the department or agency in which they received the Contingent-Permanent appointment. Once appointed, there will be a probationary period of 8-52 weeks based on performance of duties.

NON-REFUNDABLE FILING FEE: Payment must accompany the application in the form of check or money order made payable to **City of Kingston Comptroller**. Include your name, examination number and title on the check/money order. Cash payments are NOT accepted. If your application is disapproved, the fees will NOT be returned to you. If you are approved and do not appear for the examination, you forfeit the fees as no refunds will be made.

<u>FILING DEADLINE</u>: All applications and filing fees must be received in the Kingston Civil Service Office no later than 4:00 pm on the filing date deadline. Postmarked mail will not be accepted if received after the filing deadline. Please do not mail applications unless you know they will be received by the deadline. The City is not responsible for applications received via mail after the filing deadline.

<u>CHANGE OF ADDRESS</u>: It is the candidate's responsibility to complete a "Change of Address Form" and turn it in to the Kingston Civil Service Office upon a change in their place of residence. This office will not accept any other change of address information if it has not been provided on, or supplemented by, this form. A candidate's address will be subject to verification prior to any appointment. Forms can be found on the Kingston website at www.kingston-ny.gov/Employment.

Scopes / Subjects of examination: A test designed to evaluate knowledge, skills and /or abilities in the following areas.

#### Ability to learn and apply information

These questions test for the ability to learn new information and apply it to answer questions effectively. Candidates will read information presented in a Training Lesson and then answer questions regarding the information and procedures covered in the Training Lesson. All information needed to answer the questions will be provided in the Training Lesson, and candidates will be able to refer to the Training Lesson when answering the questions. Some of the questions may require candidates to combine information from different portions of what has been learned in the Training Lesson. No prior knowledge of any specific job or subject matter is needed.

#### **Basic arithmetic**

This section requires candidates to use basic arithmetic (add, subtract, multiply, divide) to find a missing value in a table of numbers. Candidates will not need to refer to the Training Lesson or any other section of the test to answer the questions in this section. All information needed to answer each question will be contained in this section. No knowledge of firefighting or any other job is required. **Candidates should bring a hand-held battery- or solar-powered calculator for use on this test.** Candidates will **not** be permitted to use the **calculator** function on their **cell phone**.

#### **Reading comprehension**

These questions test for the ability to understand written materials (e.g., sentences, passages) and answer questions about the information presented. Candidates will be provided with reading passages, followed by questions related to each passage. Each question will require candidates to demonstrate that they have read and understood the information contained in the passage.

#### Situational judgment

This section tests for the ability to identify appropriate and effective responses to work-related challenges. Candidates will be presented with several scenarios that reflect the types of challenges one could encounter in a work environment. They will then be asked to rate the effectiveness of a number of possible responses to each scenario.

Candidates not having access to a computer or the internet may request copy of the test guide from the municipal civil service office conducting this examination using the contact information found elsewhere on this announcement.

<u>CALCULATOR STATEMENT</u>: Use of calculators is <u>RECOMMENDED</u>. Candidates are permitted to use quiet, hand-held, solar, or battery powered calculators. Devices with typewriter keyboards, spell checkers, personal digital assistants, address books, language translators, dictionaries, or any similar devices are prohibited.

PREPARATION/RATING OF EXAMINATIONS RULE: This examination will be prepared and rated in accordance with Section 23(2) of the Civil Service Law. The provisions of the New York State Civil Service Law, rules and regulations dealing with the preparation and rating of examinations will apply to this examination.

<u>SPECIAL ACCOMODATIONS</u>: Religious Accommodation – People with disabilities – Military Personnel – If special arrangements for testing are required, you must contact the Kingston Civil Service Office.

APPLYING FOR MULTIPLE EXAMINATIONS SCHEDULED FOR THE SAME DAY (Cross-Filing): You must notify all agencies with which you have filed an application of the test site at which you wish to take your examination(s). If you have applied for both State and Local government examinations, you must notify the Kingston Civil Service Office no later than two weeks prior to the test date of your intent to take both a State and Local government examination. When taking both a State and a Local government examination you will be required to take all your examinations at a State examination center. You will be advised by letter when and where to report for your examinations.

For City of Kingston examinations, the Cross File form must be completed. This form is available in the Kingston Civil Service Office or online at <a href="https://www.kingston-ny.gov">www.kingston-ny.gov</a>. If you do not submit your Cross File form two weeks prior to the test date, you may NOT be allowed to sit at the test site you have selected. If you appear at a test site but did not designate this location as your test site on your form, you may NOT be allowed to take your examination(s) at that location.

ALTERNATE TEST DATES: Alternate test dates may be arranged upon review of the circumstances according to the Alternate Test Date Policy established by this department, which is available on the City's website, . Upon specific circumstances an alternate test date may be arranged. If a medical emergency prevents you from appearing for the examination, please notify this office no later than 4:00 PM on the Monday following the test date (Tuesday if Monday is a holiday) providing verifiable documentation of the reason. A determination will be made if you will be scheduled for an alternate test date.

NOTIFICATION: If an application is disapproved, notice will be sent. This department does not make formal acknowledgment of the receipt of an application or take responsibility for non-delivery or postal delay. If the candidate does not receive either a disapproval letter or an admission notice mailed to the address listed on his/her application 3 days prior to the exam date, call 845-334-3921 prior to the examination date.

APPLICATION FEE WAIVER: A waiver of application fee will be allowed if you are unemployed and primarily responsible for the support of a household. In addition, a waiver of application fee will be allowed if you are determined eligible for Medicaid, or receiving Supplemental Security Income payments, or Public Assistance (Temporary Assistance for Needy Families/Family Assistance or Safety Net Assistance) or are certified Job Training Partnership Act/Workforce Investment Act eligible through a State or local social service agency. All claims for application fee waiver are subject to verification. If you can verify eligibility for application fee waiver, complete a "Request for Application Fee Waiver and Certification" form and submit it with your application by the close of business on the Application Deadline as listed on the Examination Announcement. <u>VETERAN'S CREDIT</u>: Veterans or disabled veterans who are eligible for additional credit must submit an application for veteran's credit with their application for examination or at any time between the dates of their application for examination and the date of the establishment of the resulting eligible list. Applications for veteran's credit are available on the website at <a href="www.kingston-ny.gov/Employment">www.kingston-ny.gov/Employment</a> or at the Civil Service office.

Effective January 1, 1998, the State Constitution was amended to permit a candidate currently in the armed forces to apply for and be conditionally granted veteran's credit in examinations. Any candidate who applies for such credit must provide proof of military status to receive the conditional credit. No credit may be granted after the establishment of the list. It is the responsibility of the candidate to provide appropriate documentary proof indicating that the service was in time of war, as defined in Section 85 of Civil Service Law, and that the candidate received an honorable discharge or was released under honorable conditions in order to be certified at a score including veteran's credits.

On November 5, 2013, New York State voters approved an amendment to Article 5, section 6, of the New York State Constitution regarding the award and use of additional credits for certain disabled veterans on open competitive and promotion civil service examinations for positions with New York State and local governments. Please contact the Kingston Civil Service Commission Office for details.

ADDITIONAL CREDITS FOR CHILDREN OF FIREFIGHTERS AND POLICE OFFICERS KILLED IN THE LINE OF DUTY: In conformance with section 85-a of the Civil Service Law, children of firefighters and police officers killed in the line of duty shall be entitled to receive an additional ten points in a competitive examination for original appointment in the same municipality in which his or her parent had served. If you are qualified to participate in this examination and are a child of a firefighter or police officer killed in the line of duty in this municipality, please inform this office of this matter when you submit your application for examination. A candidate claiming such credit has a minimum of two months from the application deadline to provide the necessary documentation to verify additional credit eligibility. However, no credit may be added after the eligible list has been established.
