

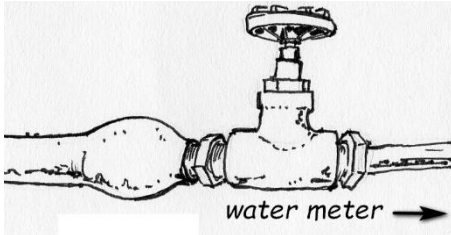

Does the pipe connected to your water meter have a bulge?

To be considered for the Lead Service Line Replacement Program the home must:

1. Be in the City of Kingston,
2. be built before 1940,
3. be a residential single or multi family property (mixed use, industrial, manufacturing and commercial properties are not eligible),
4. and a City of Kingston Housing Rehabilitation Specialist must be able to visually verify that a lead pipe is connected to the supply side of the water meter. *If the pipe connected to your water meter resembles the illustration at left, it is probably a lead pipe.*

- Using the contact information you provide the Housing Rehabilitation Specialist will make at least three attempts to make an appointment to inspect the supply side pipe of the water meter.
- Because of limited funds the City of Kingston does not guarantee your participation in the Lead Service Line Replacement Program even if the building meets all the conditions listed above.

We will also mail you the Program Guidelines upon request.

If the City's Housing Rehabilitation Specialists verify more homes with lead pipes connected to the supply side of the water meters than can be served by the estimated remaining funds:

- a. Properties with residents with verified elevated blood levels will be served first.
- b. Properties with verified residents under six year of age will be served next.
- c. Lots will be drawn for the order of the remaining homes on a waiting list.
