## CITY OF KINGSTON ANNOUNCES RELEASE OF DRAFT COMPREHENSIVE PLAN FOR PUBLIC REVIEW AND COMMENT

The City of Kingston Comprehensive Plan Steering Committee is pleased to announce that a **DRAFT COMPREHENSIVE PLAN** for the City of Kingston has been prepared and is available for public review and comment. The Draft is the result of various public outreach efforts, numerous committee meetings and review of several early versions.

The Plan is available online at www.kingston-ny.gov/2025, and can be reviewed in the City of Kingston Planning Office.

A public presentation, highlighting the essential elements of the Plan, including goals and objectives for the City's future, is scheduled for Thursday, January 29, 2015, at 6:30 PM in the Common Council Chambers at Kingston City Hall, 420 Broadway, Kingston, New York 12401. After a brief presentation by consultants, public comment will be received by the Committee for review and consideration.

Chairman James Noble, Alderman at Large commented, "Updating the Comprehensive Plan is a priority that will provide a mechanism to achieve the goals enabling our municipality to focus on appropriate steps. Throughout this process it has been clearly recognized that the citizens of our City have various concerns and talents, which we have been incorporated into a blueprint for our future. With this document we hope to encourage growth and direction for our City's future. With the leadership of our consultant team, Shuster and Turner Assoc., along with the Kingston Planning Office and Steering Committee, I am confident that we have a document which is suitable for public review."

I encourage the public to review the Final Draft of the Comprehensive Plan, attend the public session and provide comment.
